Though it is a voluntary framework, it is mandatory for federal agencies and necessary for companies conducting business with the government as a contractor, partner, or vendor to comply with the standards. The NIST CSF improves cybersecurity risk management and critical infrastructure cybersecurity by providing a comprehensive view of the life cycle for managing cybersecurity risk over a period of time using five key functions - identify, protect, detect, respond, and recover. NIST CSF can conform to the organization in line with specific business practices by determining activities that are important to critical business services. Many variables influence the effort required to prepare a system for audit and authorization.
