Mental Health Awareness

Making changes to offer better assistance!

This month, HanaByte shed a spotlight on Mental Health with a reflective inner look. In order to maintain privacy for our team, we chose to spotlight different ways to encourage healthy conversations about mental illness. As a remote-first company, it is easy to both decrease the stress employees feel by social pressures and also recognize the isolation that may come from working from home. It is our responsibility to try to tackle the fine line that exists with self-paced meetings that align with the needs of our employees. Our Culture ambassador works to create monthly check-ins with the team to check their temperature on work-load management, communication, and opportunities for improvement. In addition, free conversation times are encouraged between studies and client meetings that stray from work requirements.

As an additional meter, there are some other big changes coming at HanaByte as we switch to a new benefitoffering system under a new provider with more employee support options and coverages for mental health. Employee Assistance Programs will also be offered starting in July. HanaByte continues to move forward to create a more welcoming space where the stigmatization around mental health has been removed and open dialogue can continue to occur.

Being Present in Cybersecurity Dialogue



SecureWorld Atlanta

Our team had a blast at SecureWorld Atlanta this year! Krista Arndt, CISO of United Musculoskeletal Partners, drew parallels between drag racing and cybersecurity, emphasizing rapid response and learning from failures. Arndt's lessons included understanding unique business risks, viewing compliance as a starting point, and prioritizing risk management. She stressed the importance of layered security controls, team diversity, and continuous improvement. Just as racers share information to innovate, cybersecurity professionals must exchange knowledge to stay ahead of threats.

Stanton Gatewood, CISO of the US Department of Homeland Security, discussed the evolving role of AI in cybersecurity, highlighting its potential and pitfalls. He shared an example where AI swiftly identified a malicious link among 65,000 emails, showcasing AI's efficiency when properly trained. However, Gatewood warned about the risks of adversarial AI, data poisoning, and the need for skilled oversight. The conference underscored the necessity of integrating AI thoughtfully into business processes, maintaining


